§ 1 Purpose of data processing

In order to handle your visa application for the People's Republic of China, your personal data will need to be processed (in particular, the collection, storage and use thereof). Furthermore, we shall be transmitting the data that you provided when filling out the form titled “Application for Visa Required to Enter the People's Republic Of China” to the Consulate General of The People's Republic Of China, located in Frankfurt am Main, Stresemannallee 19-23, 60596 Frankfurt am Main, which is part of this handling process.

This data shall also be processed in the Foreign Office of the People's Republic Of China (No. 2, Chaoyangmen Nandajie, Chaoyang District, Beijing, 100701), among other things by storing the data on servers used by the Foreign Office of the People's Republic Of China. The inclusion of diplomatic premises of the People's Republic of China and of the Foreign Office, plus the associated processing of personal data in the People's Republic of China, is required to ensure that the visa application is processed properly and successfully.

§ 2 Particularly sensitive data

In order to examine the visa application submitted by you, particularly sensitive personal data, which is obtained from your entries in the form titled “Application for Visa Required to Enter the People's Republic of China” directly or indirectly, shall be transmitted to the Consulate General and the Foreign Office of the People's Republic of China. For the purpose of issuing visas, this can be personal data highlighting racial and ethnic origin, religious or philosophical convictions, biometric data, health data, data on one's sexual orientation, and data relating to criminal convictions and offences.

§ 3 Ruling on appropriate level of data protection

For the People's Republic of China, there is currently no EU Commission ruling within the meaning of Art. 45 par. 3 of the General Data Protection Regulation (GDPR). This means that EU Commission has not yet determined that the level of data protection within the People's Republic of China meets the requirements of the GDPR.

§ 4 Appropriate guarantees

Alternatively, there are appropriate guarantees for data transmission to third countries in place with Art. 46 par. 1 of the GDPR, which did not previously exist.

§ 5 Potential risks

The protection of your personal data is important to us. Nevertheless, potential risks cannot be ruled out completely at present despite existing measures on data protection and data security in relation to the above-mentioned §§ 3, 4. These include in particular:

- Your personal data may be processed beyond the actual purpose originally intended and obtained by third parties.
- You may not be able to assert your right to information vis-à-vis the Consulate General and the Foreign Office of the People's Republic of China in the long term.

§ 6 Consent / revocation of consent

I agree to the transmission of my personal data specified in § 1 for the handling of the visa application submitted by me to the Consulate General and the Foreign Office of the People's Republic of China, and the associated processing of personal data in the People's Republic of China.

Revocation shall not affect the lawfulness of data processing based on consent before its withdrawal.
